The term of the chairperson and members shall be for a period of two years.

The term of the special invitee shall be one year

The terms of Reference for the committee shall be as under

1. A complaint from an aggrieved student relating to the institution shall be addressed to the Chairperson, Students' Grievance Redressal Committee (SGRC).
 - i In considering the grievances before it, the SGRC shall follow principles of natural justice.
 - ii The SGRC shall send its report with recommendations, if any, to the competent authority of the institution concerned and a copy thereof to the aggrieved student, within a period of 15 working days from the date of the receipt of the complaint.
 - iii Any student aggrieved by the decision of the students' grievance Redressal Committee may prefer an appeal to the Director, HBCH & MPMCC, Varanasi, within a period of 15 days from the date of the receipt of such decision.

Any grievance related to Medical/ Nursing /Paramedical students shall be attended by this committee and such matters shall not ordinarily be entertained by ABVMU, Lucknow. However, if the complainant is not satisfied with decision of the Student Grievance Redressal Committee, such matters along with minutes of the meeting (s) of Grievance Redressal Committee of this hospital shall be forwarded to ABVMU, Lucknow for further adjudication in the matter.
