- 6. No tender will be accepted unless the full amount of Ernest's Money Deposit (EMD) of ₹ 42,000.00 (Rupees Forty-Two Thousand Only) is paid. The Earnest Money Deposit must be paid by Demand Draft/Bankers Cheque drawn in favor of "Mahamana Pandit Madan Mohan Malaviya Cancer Centre" payable at Varanasi, to be attached along with Technical-Bid or submit the EMD amount at the cash counter of MPMMCC & obtain a receipt from cash counter. #### 8. PRE-QUALIFICATION CRITERIA

- a. The bidder should have a legal entity either of individual/partners or a body corporate which may sue or may be sued.
- b. The bidder should be competent enough to deal with the business of the tendered item technically and financially and should have adequate manpower having prescribed qualifications (Skilled & Technical) required for managing the business.
- c. Tenderer must provide evidence of having supplied to government hospitals / reputed private hospitals / reputed organizations in India with similar nature of services in the last two years and a copy of the same should be submitted.
- d. The tender document must be accompanied by a copy of PAN, Certificate of registration of firm/company registration, and GST registration Certificate.

#### 9. BIDDING PROCEDURE

- a. Bids are invited in two bid systems, (1) Technical/pre-qualification bid and (2) Commercial Bid, which shall be sealed separately by mentioning the technical bid and Commercial bid on the top of the envelope. Both of these two envelopes will be then enclosed in a single sealed envelope.
- b. No Bids will be accepted after the due date and time under any circumstances. This office will not be responsible for any postal/courier delay and also for reasons beyond the control of this office.
- c. Technical/Pre-qualification Bid must contain the EMD for a specified amount, along with complete technical details as desired by this tender. First Technical Bids of all the tenders will be opened on the pre-scheduled date, time & venue. Technical Bids without EMD will be summarily rejected.
- d. Price bids will open after evaluation & successful Technical Bid. The Department will then inform the date, time & venue to bidders for commercial bid opening.

#### 10. OPENING OF BIDS

- a. The Institute (MPMMCC/HBCH) will open the technical bids at the scheduled time, date, and venue in the presence of the bidder's representatives who chose to attend.
- b. The bidder's representatives who will be present shall sign on the paper evidencing their attendance.
- c. The firm who has submitted the bids and whose offers are found technically suitable shall be informed of the opening date of the second envelope i.e., "Price Bid (Commercial Bid)".

#### 11. BID REJECTION CRITERIA

- a. Bids without EMD would be rejected
- b. Bids without a profile and declaration on the company's letterhead would be rejected.
- c. Non-submission of bid security/EMD signed by authorized signatory in physical form.
- d. Incomplete including non-submission or non-furnishing of requisite documents are liable for rejection by the institute.

#### 12. TENDER EVALUATION CRITERIA

- a. The evaluation will be a two-stage process: 1. Technical Evaluation 2. Commercial Evaluation.
- b. The bidders shall be evaluated based on the qualifying requirements as given in Annexure
- c. Price bids will be opened only for Techno-Commercially accepted bidders.
- d. The contractor shall be awarded the work on an overall L-1 basis for the full scope of the tender.
- e. In case of a tie between two or more than two bidders for L1 price. Bids shall be called for a discount on the price offered in sealed envelopes from all the L1 bidders.
- f. The price bid shall be evaluated on an overall basis.

#### 13. TENURE OF THE CONTRACT

The CAMC contract will be valid for 2 years with effect from the date of award of the contract with terms & conditions. However, the final decision shall rest with the department only.

- **14.** Latest Government of India guidelines on the "Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012" & Subsequent amendments from time to time will be applicable. A copy of a valid UAM/URC must be submitted if available.
- **15.** The latest Government of India guidelines "Mandatory Conditions to be satisfied by any bidder from a Country which shares a land border with India" placed at Annexure E.
  - a. Self-attested copy of **Annexure E** Mandatory conditions to be satisfied by any bidder from a country that shares a land border with India. Bidder to confirm.
  - b. Certificate of compliance of clauses of **Annexure E**, clause A VII. Bidder to confirm.
  - c. Certification as per the last paragraph of **Annexure E** Mandatory conditions to be satisfied by any bidder.

#### 16. AWARD OF CONTRACT/PURCHASE ORDER

The Purchaser will award the contract/purchase order to the bidder whose quotation has been determined to be substantially responsive and who has bided the lowest evaluated quotation price.

- a. Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and cancel the bidding process, and reject all quotations at any time prior to the award of the contract.
- b. The bidder whose bid is accepted will be notified of the award of the contract by the Purchaser prior to the expiration of the bid validity period. The terms of the accepted bid shall be incorporated into the purchase order/work order.
- 17. Rates should be quoted inclusive of packing, forwarding, postage and transportation charges, etc.
- 18. The bidder will be responsible for the safe transit of the goods under proper goods insurance coverage and under standard conditions and the risk of loss in transit of the goods/services shall be the responsibility of the bidder.
- **19.** The competent authority reserves all rights to reject the goods/service if the same is not found in accordance with the required description/specifications/quality.
- **20.** If the Vendor Capability Proforma provided and the documents required as mentioned are not submitted, MPMMCC/HBCH reserves the right not to accept the offer.

#### **B. SCOPE OF WORKS**

### A brief overview of the services required is outlined below. The scope of work includes but is not limited to, the following:

- ❖ The AMC work involves Comprehensive maintenance, Network Switches (LAN networks) covering hardware, software, and replacement of defective parts/components. The contract shall cover all hardware and software under CAMC. The charges of Comprehensive AMC shall be inclusive of the cost of spare parts along with services. The tenderers are required to supply and maintain all parts as and when required for maintenance purposes and regular up-keeping Networking, and other equipment under AMC.
- Switch means all network switches (L2, L3,) and related hardware and software.
- ❖ Be ready to provide 24x7 support after working hours or on holidays (both Institute and National declared), if required.
- ❖ Each complaint must be attended to and fixed on the same day within working hours. If the component needs time for repair or replacement then an alternate temporary arrangement must be made by the bidder.
- The work is required to be done to the satisfaction of the controlling officer. The items required during CAMC to be replaced should be of OEM make.
- Do periodic preventive maintenance of all the systems once a quarter (3 months).
- Systems have to be maintained during the entire period of the contract in working condition with regular quarterly Preventive maintenance, servicing of the network hardware and software, rack maintenance, fiber cables wherever used to connect the core switch and L2 switches, etc.
- The service provider will restore any system & bring it back to its original state if any system fails. In case of a network switch crash, the recovery of data and restoration (if possible) to be a part of the AMC.
- The firm shall record the calls attended and quarterly regular services rendered and get the signature of the user along with the User's name, and department. Original call reports shall be attached with the bills for payment.
- If any part goes faulty it shall be replaced either by a similar part or a higher version.
- AMC Contractor (Bidder) will arrange complaint booking between 09:00 AM to 06:00 PM and shall maintain a register for complaints.
- Provide the full details of the escalation matrix in terms of official address, phone numbers (both fixed & mobile numbers), and working Email IDs.
- ❖ In case of repair of defective parts at the manufacturing service centre, the transportation cost, freight charges, and re-export/re-import cost including custom duty, etc. shall be borne by the contractor providing annual maintenance. It is the responsibility of the Bidder to obtain the required clearance from the appropriate authority. During the period of repair of the defective part, a standby system has to be provided by the bidder free of cost for the uninterrupted operation of the system.

The damages if occurred to the items/equipment during transit up to its supply shall be taken care of by the supplier/agent either by himself or through second party obligation by way of goods insurance to be arranged with a reputed goods insurance company and no obligation will be there on the part of the purchaser and every step whatever is required to be taken shall be initiated and taken by the agent.

#### **C. OTHER TERMS & CONDITIONS**

#### 1. PENALTY:

- A. In case the agency fails to provide any service there would be a minimum penalty of Rs. 1000/per day for each service affected.
- B. Penalty to be imposed will be subject to a maximum of the total value of the contract. In case of gross negligence and downtime, security deposited by the firm can be forfeited besides immediate cancellation of the contract.

#### 2. RIGHT OF ACCEPTANCE:

HBCH/MPMMCC reserves the right to accept or reject any or all tenders/quotations without assigning any reason thereof and also does not bind itself to accept the lowest quotation or any tender. HBCH/MPMMCC also reserves the right to accept all the items/equipment/instruments in the given tender or only part of it in any given schedule without assigning any reason.

#### 3. VALIDITY OF THE BIDS:

The bids shall be valid for a period of 180 days from the date of opening of the tender. This has to be so specified by the tenderer in the commercial bid which may be extended if required.

#### 4. RESPONSIBILITY FOR EXECUTING THE CONTRACT:

The agency is to be entirely responsible for the execution of the contract in all respects in accordance with the terms and conditions specified in the acceptance of the tender.

- A. The agency shall not sublet transfer or assign the contract or any part thereof to any third party without the written permission of The Director (MPMMCC/HBCH), Varanasi. In the event of the contractor contravening this condition, The Director, (MPMMCC/HBCH) shall be entitled to place the contract elsewhere, on the contractor's account at his risk and the agency shall be liable for any loss or damage.
- B. In all matters of a dispute relating to this contract, the decision of The Director, (MPMMCC/HBCH), Varanasi will be final and binding upon the agency.

#### 5. RISK PURCHASE & RECOVERY OF SUMS DUE:

- A. Failure or delay in service of any or all items/work as per Requisition / Purchase Order / Work Order, Specification, or brand prescribed in the tender, shall be treated as 'non-compliance' or 'breach of contract' and the order in part or full be arranged from an alternative source(s) at the discretion of the hospital authority and the difference in price has to be recovered from the tenderer as mentioned elsewhere.
- B. The amount will be recovered from any of his subsequent/pending bills or security deposit.
- C. In case the sum of the above is insufficient to cover the full amount recoverable, the contractor shall pay to the purchaser, on-demand the remaining balance due.

#### 6. COMMUNICATION OF ACCEPTANCE:

HBCH / MPMMCC, Varanasi reserves all right to reject any tender including those tenderers who fail to comply with the instructions without assigning any reason whatsoever and does not bind itself to accept the lowest or any specific tender. The decision of this Institute in this regard will be final and binding.

#### 7. INSOLVENCY ETC.:

In the event of the firm being adjudged insolvent or having a receiver appointed for it by a court or any other under the Insolvency Act made against them or in the case of a company passing any resolution or making of any order for winding up, whether voluntary or otherwise or in the event of the firm failing to comply with any of the conditions herein specified, HBCH /MPMMCC, Varanasi shall have the power to terminate the contract without any prior notice.

#### 8. FORCE MAJEURE:

If at any time during the subsistence of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reasons of any war or hostility, the act of a public enemy, civil commotion, sabotage, fire, floods, exception, epidemics, quarantine restriction, strikers lockout or act of God (hereinafter referred to as events) provided notice of happening of any such eventuality is given by a party to other within 21 days from the date of occurrence thereof, neither party hall by reason of such event be entitled to terminate this contract nor shall either party have any claim for damages against other in respect of such non-performance or delay in performance and deliveries have been so resumed or not shall be final and conclusive.

Further, if the performance in whole or in part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days, HBCH / MPMMCC, Varanasi party may, at least option to terminate the contract.
