- 4. After opening the technical bid, the **Documents** submitted by the respective tenderers will be evaluated and the **Commercial Bid** (financial bid) will be opened only to technically qualified tenderers. The time and date will be intimated to such tenderers.
- 5. Time and date of opening of Part II- Commercial Bid will be intimated only to the tenderers who will be qualified after evaluation of Part I- (Technical Bid) i.e., Part II of the tenders will be opened on a date to be intimated later, only if Part I of the bid is technically accepted. <u>Only technically qualified and commercially lowest offers will be considered for further process.</u>
- 6. No tender will be accepted unless the full amount of Ernest's Money Deposit (EMD) of ₹ 12,744.00 (Rupees Twelve Thousand Seven Hundred Forty-Four) is paid. The Earnest Money Deposit must be paid by Demand Draft/Bankers Cheque drawn in favor of "Mahamana Pandit Madan Mohan Malaviya Cancer Centre" payable at Varanasi, to be attached along with Technical-Bid or submit the EMD amount at the cash counter of MPMMCC & obtain a receipt from cash counter. The original EMD receipt must be enclosed along with the tender document (Technical-Bid Part-I). The EMD Receipt number/DD No. and the date should be mentioned on the envelopes (i.e., Technical-Bid Part-I & Price-Bid Part-II). The copy of the EMD receipt/DD No. must be kept with the vendor and to be shown at the time of tender submission.

# Exemption against submission of EMD will be applicable as per prevailing rules of the Government of India under GFR.

Relaxation in Bidder pre-qualification criteria will be applicable as per prevailing rules and norms for "Startups" by the Government of India.

7. No tender will be accepted unless the Bid Security Declaration is enclosed along with PART I- TECHNICAL BID of the tender document.

#### 8. PRE-QUALIFICATION CRITERIA

- a. The bidder should have a legal entity either of individual/partners or a body corporate which may sue or may be sued.
- b. The bidder should be competent enough to deal with the business of the tendered item technically and financially and should have adequate manpower having prescribed qualifications (Skilled & Technical) required for managing the business.
- c. Tenderer must provide evidence of having supplied to government hospitals / reputed private hospitals / reputed organizations in India with similar nature of services in the last two years and a copy of the same should be submitted.
- d. The tender document must be accompanied by a copy of PAN, Certificate of registration of firm/ company registration, and GST registration Certificate.

### 9. BIDDING PROCEDURE

- a. Bids are invited in two bid systems, (1) Technical/pre-qualification bid and (2) Commercial Bid, which shall be sealed separately by mentioning the technical bid and Commercial bid on the top of the envelope. Both of these two envelopes will be then enclosed in a single sealed envelope.
- b. No Bids will be accepted after the due date and time under any circumstances. This office will not be responsible for any postal/courier delay and also for reasons beyond the control of this office.
- c. Technical/Pre-qualification Bid must contain the EMD for a specified amount, along with complete technical details as desired by this tender. First Technical Bids of all the tenders will be opened on the pre-scheduled date, time & venue. Technical Bids without EMD will be summarily rejected.
- d. Price bids will open after evaluation & successful Technical Bid. The Department will then inform the date, time & venue to bidders for commercial bid opening.

### 10. OPENING OF BIDS

- a. The Institute (HBCH & MPMMCC) will open the technical bids at the scheduled time, date, and venue in the presence of the bidder's representatives who chose to attend.
- b. The bidder's representatives who will be present shall sign on the paper evidencing their attendance.
- c. The firm who has submitted the bids and whose offers are found technically suitable shall be informed of the opening date of the second envelope i.e., "Price Bid (Commercial Bid)".

### 11. BID REJECTION CRITERIA

- a. Bids without EMD would be rejected
- b. Bids without a profile and declaration on the company's letterhead would be rejected.
- c. Non-submission of bid security/EMD signed by authorized signatory in physical form.
- d. Incomplete including non-submission or non-furnishing of requisite documents are liable for rejection by the institute.

## 12. TENDER EVALUATION CRITERIA

- a. The evaluation will be a two-stage process: **1.** Technical Evaluation **2**. Commercial Evaluation.
- b. The bidders shall be evaluated based on the qualifying requirements as given in Annexure
- c. Price bids will be opened only for Techno-Commercially accepted bidders.
- d. The contractor shall be awarded the work on an overall L-1 basis for the full scope of the tender.
- e. In case of a tie between two or more than two bidders for L1 price. Bids shall be called for a discount on the price offered in sealed envelopes from all the L1 bidders.
- f. The price bid shall be evaluated on an overall basis.

## 13. TENURE OF THE CONTRACT

The CAMC contract will be valid for 1 year with effect from the date of award of the contract with terms & conditions. However, the final decision shall rest with the department only.

- 14. Latest Government of India guidelines on the "Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012" & Subsequent amendments from time to time will be applicable. A copy of a valid UAM/URC must be submitted if available.
- **15.** The latest Government of India guidelines "Mandatory Conditions to be satisfied by any bidder from a Country which shares a land border with India" placed at Annexure E.
  - a. Self-attested copy of **Annexure E** Mandatory conditions to be satisfied by any bidder from a country that shares a land border with India. Bidder to confirm.
  - b. Certificate of compliance of clauses of Annexure E, clause A VII. Bidder to confirm.
  - c. Certification as per the last paragraph of **Annexure E** Mandatory conditions to be satisfied by any bidder.

## 16. AWARD OF CONTRACT/PURCHASE ORDER

The Purchaser will award the contract/purchase order to the bidder whose quotation has been determined to be substantially responsive and who has bided the lowest evaluated quotation price.

- a. Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and cancel the bidding process, and reject all quotations at any time prior to the award of the contract.
- b. The bidder whose bid is accepted will be notified of the award of the contract by the Purchaser prior to the expiration of the bid validity period. The terms of the accepted bid shall be incorporated into the purchase order/work order.
- 17. Rates should be quoted inclusive of packing, forwarding, postage and transportation charges, etc.
- **18.** The bidder will be responsible for the safe transit of the goods under proper goods insurance coverage and under standard conditions and the risk of loss in transit of the goods/services shall be the responsibility of the bidder.
- **19.** The competent authority reserves all rights to reject the goods/service if the same is not found in accordance with the required description/specifications/quality.

## B. SCOPE OF WORKS

# A brief overview of the services required is outlined below. The scope of work includes but is not limited to, the following:

#### A. Basic Requirements:

The developer must follow guidelines for Government of India websites GIGW 3.0 to ensure proper standardization of all content website needs to be designed with dynamic features for updating and prescribed web accessibility features as below.

- 1. Least site opening time
- 2. Clean and professional design
- 3. Search engine-friendly website
- 4. Security of the website
- 5. Compliance with regulatory guidelines /orders

The website is already developed and functional. During the maintenance contract period, the website should be able to handle dynamic content, and it should have the ability to get updated as a multilingual website (mostly English and Hindi). It should be able to support Video Content without Plugins, if any, and also Support Search Engine Optimization. The following are basic functional required under the maintenance contract.

- 1. **Regular Updates**: Ensuring all website software, including the all plugins, and themes, are up-todate. The theme may be changed anytime as per the guidelines on websites issued by Tata Memorial Centre Mumbai and GIGW 3.0. issued by Govt. of India.
- Security Monitoring: Continuous security monitoring for vulnerability assessment and implementing necessary security patches to protect against cyber threats. A Quarterly Vulnerability Assessment and Penetration Testing (VAPT) clearance certificate is required to be submitted as the part of maintenance activity.
- 3. **Performance Optimization**: Regular checks and optimizations for website speed and responsiveness to improve user experience.
- 4. **Content Updates**: Assisting with the addition, deletion, or modification of website content as per the client's request.
- 5. **Technical Support**: Providing prompt technical support for any issues related to the website's functionality.
- 6. **Backup Services**: Regularly scheduled backups of the website's data to ensure no critical information is lost.
- 7. **Analytics Reporting**: Monthly reporting on website performance metrics, including visitor statistics, engagement rates, and other relevant analytics.

A quarterly assessment of the website on the above-mentioned basic requirements with recommendations to improve the overall user experience is required to be submitted.

#### B. Website Update Requirements:

- 1. The updated changes must be designed with a robust user interface and user experience to ensure that the services are user-friendly.
- 2. The updated change must be designed with consistent visual elements and architecture that is scalable and expandable.
- 3. The website architecture should be able to address future scalability requirements.

### E. Legal Requirement:

Website and related pages are to be made "Accessible for all" (i.e., Divyangjan friendly). The compliance with the Record of Proceedings dated 30.07.2024 w.r.t. Case No. CCPD/15519/1101/2024 and CCPD/15530/1101/2024 in the matter of Suo-motu cognizance regarding inaccessibility of websites, mobile applications, and other digital platforms of ministries/departments of the Government of India and Private establishments in the country- Regarding.

# C. OTHER TERMS & CONDITIONS

#### 1. **PENALTY**:

- A. In case the agency fails to provide any service there would be a minimum penalty of Rs. 1000/per day for each service affected.
- B. Penalty to be imposed will be subject to a maximum of the total value of the contract. In case of gross negligence and downtime, security deposited by the firm can be forfeited besides immediate cancellation of the contract.

#### 2. RIGHT OF ACCEPTANCE:

#### 3. VALIDITY OF THE BIDS:

The bids shall be valid for a period of 180 days from the date of opening of the tender. This has to be so specified by the tenderer in the commercial bid which may be extended if required.

### 4. RESPONSIBILITY FOR EXECUTING THE CONTRACT:

The agency is to be entirely responsible for the execution of the contract in all respects in accordance with the terms and conditions specified in the acceptance of the tender.

- A. The agency shall not sublet transfer or assign the contract or any part thereof to any third party without the written permission of The Director (HBCH & MPMMCC), Varanasi. In the event of the firm being adjudged insolvent or having a receiver appointed for it by a court or any other under the Insolvency Act made against them or in the case of a company passing any resolution or making of any order for winding up, whether voluntary or otherwise or in the event of the firm failing to comply with any of the conditions herein specified, HBCH & MPMMCC, Varanasi shall have the power to terminate the contract without any prior notice.

#### 8. FORCE MAJEURE:

If at any time during the subsistence of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reasons of any war or hostility, the act of a public enemy, civil commotion, sabotage, fire, floods, exception, epidemics, quarantine restriction, strikers lockout or act of God (hereinafter referred to as events) provided notice of happening of any such eventuality is given by a party to other within 21 days from the date of occurrence thereof, neither party hall by reason of such event be entitled to terminate this contract nor shall either party have any claim for damages against other in respect of such non-performance or delay in performance and deliveries have been so resumed or not shall be final and conclusive.
