8. PRE-QUALIFICATION CRITERIA

- a. The bidder should have a legal entity either of individual/partners or a body corporate which may sue or may be sued.
- b. The bidder should be competent enough to deal with the business of the tendered item technically and financially and should have adequate manpower having prescribed qualifications (Skilled & Technical) required for managing the business.
- c. Tenderer must provide evidence of having supplied to government hospitals / reputed private hospitals / reputed organizations in India with similar nature of services in the last two years and a copy of the same should be submitted.
- d. The tender document must be accompanied by a copy of PAN, Certificate of registration of firm/company registration, and GST registration Certificate.

9. BIDDING PROCEDURE

- a. Bids are invited in two bid systems, (1) Technical/Pre-qualification Bid and (2) Commercial Bid, which shall be sealed separately by mentioning the technical bid and Commercial bid on the top of the envelope. Both of these two envelopes will be then enclosed in a single sealed envelope.
- b. No Bids will be accepted after the due date and time under any circumstances. This office will not be responsible for any postal/courier delay and also for reasons beyond the control of this office.
- c. Technical/Pre-qualification Bid must contain the EMD for a specified amount, along with complete technical details as desired by this tender. First Technical Bids of all the tenders will be opened on the pre-scheduled date, time & venue. Technical Bids without EMD will be summarily rejected.
- d. Price bids will open after evaluation & successful Technical Bid. The Department will then inform the date, time & venue to bidders for commercial bid opening.

10. OPENING OF BIDS

- a. The Institute (HBCH & MPMMCC) will open the technical bids at the scheduled time, date, and venue in the presence of the bidder's representatives who chose to attend.
- b. The bidder's representatives who will be present shall sign on the paper evidencing their attendance.
- c. The firm who has submitted the bids and whose offers are found technically suitable shall be informed of the opening date of the second envelope i.e., "Price Bid (Commercial Bid)".

11. BID REJECTION CRITERIA

12. TENDER EVALUATION CRITERIA

- a. The evaluation will be a two-stage process: 1. Technical Evaluation 2. Commercial Evaluation.
- b. The bidders shall be evaluated based on the qualifying requirements as given in Annexure
- c. Price bids will be opened only for Techno-Commercially accepted bidders.
- d. The contractor shall be awarded the work on an overall L-1 basis for the full scope of the tender.
- e. In case of a tie between two or more than two bidders for L1 price. Bids shall be called for a discount on the price offered in sealed envelopes from all the L1 bidders.
- f. The price bid shall be evaluated on an overall basis.
- 13. Latest Government of India guidelines on the "Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012" & Subsequent amendments from time to time will be applicable. A copy of a valid UAM/URC must be submitted if available.

B. SCOPE OF WORKS

The Scope of work for the Comprehensive Cyber Security Review would be as per the Guidelines of CERT-IN and would be under the following broad categories:

A. Background and Objective of the Assignment:

The institute (HBCH & MPMMCC) would like to engage a third-party firm to perform services including a cyber security audit, review of their existing IT policies, and creation of IT policies in line with ISO 27001 and ISMS readiness. The overall purpose of the Cyber Security Audit exercise is to conform to the IT security needs of quality standard ISO 27001, which includes the evaluation and gap analysis of the following with respect to CERT-IN guidelines:

- Current IT infrastructure of the institute.
- Network and devices in use.
- Operating systems and databases at the Server level and User level.
- Application packages and databases.
- IT Policies including Operational Procedures in the current IT setup at the institute.
- Identification of vulnerabilities, security flaws, gaps, and loopholes.

The main objective of this project is to engage CERT-IN empaneled auditors, to audit the security implementation across HBCH & MPMMCC IT Infrastructure, including its web-based applications. The agency will also assist the HBCH & MPMMCC in the identification of the vulnerabilities during assessment & provide recommendations to cope with encountered vulnerabilities.

B. Broad Scope of Cyber Security Audit:

- Conduct a Cyber security Audit of HBCH & MPMMCC IT Infrastructure in conformance with the Information and Cyber Security Policy of HBCH & MPMMCC and the latest version of "Cyber Security Audit Baseline Requirements" by National Security Council Secretariat followed by CERT-IN and ascertain the ISO 27001 and ISMS readiness.
- 2. The scope of the Audit shall broadly cover the following areas:
 - Current IT infrastructure of HBCH & MPMMCC
 - Information security policies / TMC ISMS Framework
 - Human resource security
 - Asset management
 - Access control
 - Physical and environmental security
 - Operations Security
 - Communications/Network Security
 - Vendor/Service provider relationships
 - Information security incident management
 - Information security aspects of business continuity management
- 3. The detailed scope of the Cyber Security Review shall comprise of: -
 - Network Architecture Review
 - Vulnerability Assessment & Penetration Testing
 - Configuration Audit of Network & Security Devices
 - Firewalls Rules Review

- Configuration Audit of Servers
- Network Performance Testing
- External Penetration Testing
- Re-Scan (Closure Audit)
- 4. Conduct Vulnerability Assessment /Penetration Test for IT setup of HBCH & MPMMCC, Website, and network, wherever necessary. Based on the findings, suggest corrective actions/redressals/mitigation of risks/Non-Conformities (NCs), with the objective of enhancing the security posture of the information systems.
- 5. Review existing IT and cybersecurity policies and procedures and recommend suitable measures for adopting best practices in line with ISO 27001 and ISMS readiness.
- 6. Recommend a suitable Cyber Crisis Management Plan (CCMP) for HBCH & MPMMCC IT facilities, for consideration of the authority, which will contain a strategy followed in case of a Cyber-attack or threat.
- 7. Security audit of the website should clearly state that with implementation of remedies / measures suggested for all web pages along with respective linked data files (in pdf / doc / xls formats), all scripts and image files shall be free from any vulnerability or malicious code, which could be exploited to compromise and gain unauthorized access with escalated privileges into the web server system hosting the said website.
- 8. The report should contain: -
 - Dates and locations (s) of audit preliminary and final audit plan.
 - Additional mandatory or voluntary standards or regulations applicable to the auditor.
 - Summary of audit findings including identification tests, tools used, and results of tests performed.
 - Analysis of vulnerabilities and issues of concern.
 - Recommendations for action.
 - Personnel involved in the audit.
 - In addition to this, the report should include all unknowns clearly marked as unknowns.
- 9. HBCH & MPMMCC shall get the vulnerabilities removed and subsequently the auditor shall audit again and submit a final formal IT security audit report. The successful bidder on a successful security audit furnishes a security Certificate for IT infrastructure and Website as per CERT-IN norms stating that HBCH & MPMMCC Data centre and website are completely safe from internal & external threats. Bidder will Certify the Web applications/website tested as "Safe for Hosting".
- 10. The successful bidder is expected to carry out an assessment of the vulnerabilities, threats, and risks that may exist in the institute (HBCH & MPMMCC) and website for internet vulnerability assessment and penetration testing, which includes identifying remedial solutions and recommendations for implementation of the same to mitigate all identified risks, with the objective of enhancing the security of the institute data centre, website, and the other integrated applications.
- 11. The successful bidder is required to submit the audit report (preliminary and intermediate) clearly stating the observations and remedial measures suggested for the subjected component.
- 12. The successful bidder shall be required to provide support in implementing the suggested remedial measures and patching as required.
- 13. The successful bidder will submit a separate final report indicating about the status of found vulnerabilities and recommendations for action after completion of the security Audit / Assessment of IT Infrastructure, applications, and website.

C. Other Requirements of Comprehensive Cyber Security Audit:


- CSAF Audit: An audit has to be carried out as per the CERT-IN guidelines and the Cyber Security
 Assessment Framework (CSAF) Version 2. The audit will include a compliance audit as per CSAF markers
 along with a technical sampling audit for evidence gathering. The scope of work would cover the following
 areas:
 - Assessment against CSAF markers and evidence collection
 - Gap Analysis against CSAF
 - Documented evidence
 - Compliance audits
- 2. Operating Systems and System Software such as Server Software, Domain Controller Server, Server Hardware such as Rack Servers, etc. The audit will include the server vulnerability assessment, pack, and service patch updates, backdoor checks, and default configuration.
- 3. Network connections of leased lines between MPMMCC and HBCH. Routers & Firewalls in the institutes. Controls of Internet and other network access to various end-users by firewalls and anti-virus policies. The audit will include the network architecture review, network vulnerability assessment, and network configuration review based on the vulnerability assessment. The bidder is supposed to analyze all reports, logs, etc. of the cyber security devices installed in the institute and provide input on cyber security policies for the same.
 - End user device audit: admin/user password control, license control, OS patches, updates, virus updates, shared folders access control, use of external devices, and presence of unnecessary software.
 - Application audit: An audit has to be carried out on all the Software Applications and Packages that are exposed to the Internet.
- 4. The bidder shall review and recommend IT and Cyber Security policies (Internal) for MPMMCC/HBCH. The policies shall include the themes as mentioned in deliverables and any additional theme identified in the Audit report and not included in the scope. The selected agency shall recommend a suitable Cyber Crisis Management Plan (CCMP) for HBCH & MPMMCC IT facilities, for consideration of the authority and will contain a strategy followed in case of a Cyber-attack or threat in HBCH & MPMMCC.
- 5. The selected bidder should provide the below-mentioned details at the starting of the Cyber Security Audit exercise:

This was due to the foresight and the vision of Dr. Homi Jehangir Bhabha, who envisaged the major role that radiation would play in cancer treatment -from imaging to staging and actual therapy. The TMH and CRI merged as the two arms of the Tata Memorial Centre (TMC) in 1966 represented a classic example of private philanthropy augmented by Government support, with a mandate for Service, Education and Research in cancer.

Homi Bhabha Cancer Hospital (HBCH) and Mahamana Pandit Madan Mohan Malaviya Cancer Centre (MPMMCC), Varanasi are the units of Tata Memorial Centre, Mumbai (Grant-in-Aid Institution of Department of Atomic Energy, Government of India). Both HBCH and MPMMCC were formally inaugurated by Hon'ble Prime Minister, Shri Narendra Modi Ji on Tuesday, the 19th February 2019, in the presence of the Hon'ble Governor of Uttar Pradesh, Shri Ram Naik, Hon'ble Chief Minister of Uttar Pradesh, Shri Yogi Adityanath; the Secretary, Department of Atomic Energy, Govt. of India, Dr. K.N. HBCH has been named in honor of Dr. Homi Jehangir Bhabha (1909-1966), an Indian Nuclear Physicist and Founder Director of the Atomic Energy Establishment (now called as Bhabha Atomic Research Centre), who strived to promote nuclear power programs in India. He was awarded the Padma Bhushan in 1954. He was also nominated for the prestigious Nobel Prize for Physics in 1951 and 1953-1956.

MPMMCC has been named in honor of Mahamana Pandit Madan Mohan Malaviya (1861-1946), an Indian educationalist, who strived to promote modern education among Indians and eventually co-founded the Banaras Hindu University (BHU) at Varanasi in 1916. Malaviya Ji was a multifaceted personality- he was a great patriot, a visionary, social reformer, a passionate journalist, a successful lawyer and an outstanding parliamentarian and statesman. He was the Vice Chancellor of the Banaras Hindu University from 1919 to 1938. In his lifetime, Banaras Hindu University came to be known as a Capital of Knowledge across India and abroad.

HBCH, the erstwhile Indian Railway Cancer Hospital, was renovated by Tata Memorial Centre with the help of Tata Trusts and was made functional from 1st May 2018. MPMMCC was created as a green field project and constructed from scratch in a record time of 10 months between April 2018 to February 2019. Tata Trusts supported the construction of entire building and the equipment and manpower support were provided by Department of Atomic Energy, Govt. of India.
